In Austria youth information is an essential part of out of school youth work, which is on the national level a concern of the Federal ministry for Social Security, Generations and Consumerism. Additionally actions, measures and projects in the field of youth information are supported following the Federal law on Supportive Measures for the Youth. The department for youth policy in the ministry works in cooperation with the youth departments of the Austrian federal states, the national representation of youth (BJV), the ARGE Austrian Youth Information and ARGE Participation. The ARGE Austrian Youth Information has signed the EYRICA-charta and has developed quality standards for the Austrian youth information according to this charta.
